

## PhillipMart Announces Pre-IPO Share Price of Shunfeng Photovoltaic International Limited (Stock code: 01165)

(Hong Kong – 12 Jul,2011) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Shunfeng Photovoltaic International Limited** ("Shunfeng Photovoltaic"; stock code: 01165) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Shunfeng Photovoltaic** on PhillipMart were HK\$1.10 and HK\$1.10. The price closed at HK\$1.10 per share, 0.89% lower than its offer price of HK\$1.11.
