

**PhillipMart Announces Pre-IPO Share Price of
 Golden Shield Holdings (Industrial) Limited (Stock code: 02123)**

(Hong Kong – 13 July 2011) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Golden Shield Holdings (Industrial) Limited** (“Golden Shield”; stock code: 02123) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Golden Shield** on PhillipMart were HK\$0.72 and HK\$0.66. The price closed at HK\$0.67 per share, 4.28% lower than its offer price of HK\$0.70. The price opened at HK\$0.72, with the most actively traded price of HK\$0.68 per share, and a turnover of 4,096,000 shares. The total trading volume reached 7,776,000.00 shares with total turnover of HK\$5,311,800.00. The final price of **Golden Shield**, to debut trading tomorrow has been fixed at HK\$0.70 per share.
