

**PhillipMart Announces Pre-IPO Share Price of  
 China Fiber Optic Network System Group Ltd. (Stock code: 03777)**

(Hong Kong – 13Jul Aug 2011) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **China Fiber Optic Network System Group Ltd.** (“**China Fiber Optic**”; stock code: 03777) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **China Fiber Optic** on PhillipMart were HK\$1.24 and HK\$1.20. The price closed at HK\$1.23 per share, 2.5% higher than its offer price of HK\$1.20. The price opened at HK\$1.24, with the most actively traded price of HK\$1.20 per share, and a turnover of 136,000shares. The total trading volume reached 166,000shares with total turnover of HK\$200,320.00. The final price of **China Fiber Optic**, to debut trading tomorrow has been fixed at HK\$1.20 per share.
