

## PhillipMart Announces Pre-IPO Share Price of Prince Frog International Holdings Limited (Stock code: 01259)

(Hong Kong – 14Jul 2011) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Prince Frog International Holdings Limited** ("**Prince Frog**"; stock code: 01259) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Prince Frog** on PhillipMart were HK\$2.85 and HK\$2.39. The price closed at HK\$2.53 per share, 2.68% lower than its offer price of HK\$2.60. The price opened at HK\$2.78, with the most actively traded price of HK\$2.43 per share, and a turnover of 776,000shares. The total trading volume reached 4,985,000shares with total turnover of HK\$12,457,540.00. The final price of **Prince Frog**, to debut trading tomorrow has been fixed at HK\$2.60 per share.
