

PhillipMart Announces Pre-IPO Share Price of Active Group Holdings Limited (Stock code: 01096)

(Hong Kong – 27 Sep 2011) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Active Group Holdings Limited** ("Active Group"; stock code: 01096) on PhillipMart, an automated electronic platform for pre-IPO shares trading.
