

## PhillipMart Announces Pre-IPO Share Price of Forton Group Limited (Stock code: 01152)

(Hong Kong – 27 Oct 2011) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Forton Group Limited** ("Forton Group"; stock code: 01152) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Forton Group** on PhillipMart were HK\$0.54 and HK\$0.53. The price closed at HK\$0.54 per share, 8% higher than its offer price of HK\$0.50. The price opened at HK\$0.53, with the most actively traded price of HK\$0.53 per share, and a turnover of 652,000 shares. The total trading volume reached 920,000 shares with total turnover of HK\$490,280. The final price of **Forton Group**, to debut trading tomorrow has been fixed at HK\$0.50 per share.
