

PhillipMart Announces Pre-IPO Share Price of Sitoy Group Holdings Limited (Stock code: 01023)

(Hong Kong – 5 Dec 2011) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Sitoy Group Holdings Limited** ("**Sitoy Group**"; stock code: 01023) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Sitoy Group** on PhillipMart were HK\$3.10 and HK\$3.05. The price closed at HK\$3.07 per share, 4.07% higher than its offer price of HK\$2.95. The price opened at HK\$3.09, with the most actively traded price of HK\$3.09 per share, and a turnover of 364,000shares. The total trading volume reached 880,000shares with total turnover of HK\$2,719,800.00. The final price of **Sitoy Group**, to debut trading tomorrow has been fixed at HK\$2.95 per share.
