

PhillipMart Announces Pre-IPO Share Price of China Outfitters Holdings Limited (Stock code: 01146)

(Hong Kong – 8 Dec 2011) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **China Outfitters Holdings Limited** ("China Outfitters"; stock code: 01146) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **China Outfitters** on PhillipMart were HK\$1.69 and HK\$1.67. The price closed at HK\$1.68 per share, 2.44% higher than its offer price of HK\$1.64. The price opened at HK\$1.67, with the most actively traded price of HK\$1.68 per share, and a turnover of 1,688,000shares. The total trading volume reached 2,108,000shares with total turnover of HK\$3,541,280.00. The final price of **China Outfitters**, to debut trading tomorrow has been fixed at HK\$1.64 per share.
