

**PhillipMart Announces Pre-IPO Share Price of
 OTO Holdings Limited (Stock code: 06880)**

(Hong Kong – 12 Dec 2011) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **OTO Holdings Limited** (“OTO Holdings”; stock code: 06880) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for OTO Holdings on PhillipMart were HK\$1.70 and HK\$1.54. The price closed at HK\$1.55 per share, 1.89% higher than its offer price of HK\$1.58. The price opened at HK\$1.70, with the most actively traded price of HK\$1.59 per share, and a turnover of 726,000shares. The total trading volume reached 3,104,000shares with total turnover of HK\$4,970,700.00. The final price of OTO Holdings, to debut trading tomorrow has been fixed at HK\$1.58 per share.
