

**PhillipMart Announces Pre-IPO Share Price of
 New China Life Insurance Company Ltd. (Stock code: 01336)**

(Hong Kong – 14 Dec 2011) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **New China Life Insurance Company Ltd.** (“**New China Life**”; stock code: 01336) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **New China Life** on PhillipMart were HK\$27.15 and HK\$26.90. The price closed at HK\$27.00 per share, 5.25% lower than its offer price of HK\$28.50.
