

PhillipMart Announces Pre-IPO Share Price of Chow Tai Fook Jewellery Group Limited (Stock code: 01929)

(Hong Kong – 14 Dec 2011) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Chow Tai Fook Jewellery Group Limited** ("Chow Tai Fook"; stock code: 01929) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Chow Tai Fook** on PhillipMart were HK\$14.30 and HK\$14.00. The price closed at HK\$14.22 per share, 5.19% lower than its offer price of HK\$15.00. The price opened at HK\$14.30, with the most actively traded price of HK\$14.10 per share, and a turnover of 1,818,000 shares. The total trading volume reached 4,032,600 shares with total turnover of HK\$56,999,324. The final price of **Chow Tai Fook**, to debut trading tomorrow has been fixed at HK\$15.00 per share.
