

**PhillipMart Announces Pre-IPO Share Price of
 China Weaving Materials Holdings Limited (Stock code: 03778)**

(Hong Kong – 21 Dec 2011) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **China Weaving Materials Holdings Limited** (“**China Weaving**”; stock code: 03778) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **China Weaving** on PhillipMart were HK\$0.76 and HK\$0.72. The price closed at HK\$0.72 per share, 2.86% higher than its offer price of HK\$0.70. The price opened at HK\$0.74, with the most actively traded price of HK\$0.74 per share, and a turnover of 220,000shares. The total trading volume reached 248,000shares with total turnover of HK\$183,760.00. The final price of **China Weaving**, to debut trading tomorrow has been fixed at HK\$0.70 per share.
