

PhillipMart Announces Pre-IPO Share Price of Huazhong Holdings Company Limited (Stock code: 6830)

(Hong Kong – 11 Jan 2012) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Huazhong Holdings Company Limited** ("Huazhong Holdings"; stock code: 06830) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Huazhong Holdings on PhillipMart were HK\$1.45 and HK\$1.45. The price closed at HK\$1.45 per share, 3.57% higher than its offer price of HK\$1.40. The price opened at HK\$1.45, with the most actively traded price of HK\$1.45 per share, and a turnover of 120,000 shares. The total trading volume reached 120,000 shares with total turnover of HK\$174,000. The final price of Huazhong Holdings, to debut trading tomorrow has been fixed at HK\$1.40 per share.
