

PhillipMart Announces Pre-IPO Share Price of Allied Cement Holdings Limited (Stock code: 01312)

(Hong Kong – 17 Jan 2012) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Allied Cement Holdings Limited** ("Allied Cement"; stock code: 01312) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Allied Cement** on PhillipMart were HK\$1.15 and HK\$1.08. The price closed at HK\$1.15 per share, 15% higher than its offer price of HK\$1.00. The price opened at HK\$1.08, with the most actively traded price of HK\$1.12 per share, and a turnover of 54,000shares. The total trading volume reached 108,000 shares with total turnover of HK\$120,300. The final price of **Allied Cement**, to debut trading tomorrow has been fixed at HK\$ 1.00per share.
