

**PhillipMart Announces Pre-IPO Share Price of  
 Vision Fame International Holding Limited (Stock code: 01315)**

(Hong Kong – 17 Jan 2012) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Vision Fame International Holding Limited** (“Vision Fame”; stock code: 01428) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Vision Fame** on PhillipMart were HK\$1.30 and HK\$1.30. The price closed at HK\$1.30 per share, 8.33% higher than its offer price of HK\$1.20. The price opened at HK\$1.30, with the most actively traded price of HK\$1.30 per share, and a turnover of 100,000shares. The total trading volume reached 100,000shares with total turnover of HK\$130,000.00. The final price of **Vision Fame**, to debut trading tomorrow has been fixed at HK\$1.20 per share.
