

**PhillipMart Announces Pre-IPO Share Price of  
 Perfect Shape (PRC) Holdings Limited (Stock code: 01830)**

(Hong Kong – 9 Feb 2012) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Perfect Shape (PRC) Holdings Limited** (“Perfect Shape”; stock code: 01830) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Perfect Shape** on PhillipMart were HK\$0.97 and HK\$0.92. The price closed at HK\$0.95 per share, 7.95% higher than its offer price of HK\$0.88. The price opened at HK\$0.94, with the most actively traded price of HK\$0.95 per share, and a turnover of 1,668,000shares. The total trading volume reached 5,928,000shares with total turnover of HK\$5,585,800.00. The final price of **Perfect Shape**, to debut trading tomorrow has been fixed at HK\$0.88 per share.
