

PhillipMart Announces Pre-IPO Share Price of Christine International Holdings Limited (Stock code: 01210)

(Hong Kong – 22 Feb 2012) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Christine International Holdings Limited** ("**Christine**"; stock code: 01210) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Christine** on PhillipMart were HK\$1.65 and HK\$1.62. The price closed at HK\$1.63 per share, 1.87% higher than its offer price of HK\$1.60. The price opened at HK\$1.63, with the most actively traded price of HK\$1.63 per share, and a turnover of 296,000shares. The total trading volume reached 664,000shares with total turnover of HK\$1,085,620.00. The final price of **Christine**, to debut trading tomorrow has been fixed at HK\$1.60 per share.
