

## PhillipMart Announces Pre-IPO Share Price of Xiwang Special Steel Company Limited (Stock code: 01266)

(Hong Kong – 22 Feb 2012) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Xiwang Special Steel Company Limited** ("**Xiwang Steel**"; stock code: 01266) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Xiwang Steel** on PhillipMart were HK\$2.38 and HK\$2.28. The price closed at HK\$2.33 per share, 12.07% lower than its offer price of HK\$2.65. The price opened at HK\$2.38, with the most actively traded price of HK\$2.35 per share, and a turnover of 136,000shares. The total trading volume reached 518,000shares with total turnover of HK\$1,209,960.00. The final price of **Xiwang Steel**, to debut trading tomorrow has been fixed at HK\$2.65 per share.
