

**PhillipMart Announces Pre-IPO Share Price of
 Sunshine Oilsands Ltd. (Stock code: 02012)**

(Hong Kong – 29 Feb 2012) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Sunshine Oilsands Ltd.** (“**Sunshine Oil**”; stock code: 02012) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Sunshine Oil** on PhillipMart were HK\$4.85 and HK\$4.80. The price closed at HK\$4.80 per share, 1.22% lower than its offer price of HK\$4.86. The price opened at HK\$4.85, with the most actively traded price of HK\$4.80 per share, and a turnover of 220,000shares.
