

**PhillipMart Announces Pre-IPO Share Price of
 Wonderful Sky Financial Group Holdings Limited (Stock code: 01260)**

(Hong Kong – 29 Mar 2012) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Wonderful Sky Financial Group Holdings Limited** (“Wonderful Sky”; stock code: 01260) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Wonderful Sky** on **PhillipMart** were HK\$1.51 and HK\$1.40. The price closed at HK\$1.50 per share, 7.91 % higher than its offer price of HK\$1.39. The price opened at HK\$1.46, with the most actively traded price of HK\$1.50 per share, and a turnover of 342,000 shares. The total trading volume reached 1,134,000 shares with total turnover of HK\$1,675,280.00. The final price of **Wonderful Sky**, to debut trading tomorrow has been fixed at HK\$1.39 per share.
