

PhillipMart Announces Pre-IPO Share Price of Juda International Holdings Limited (Stock code: 01329)

(Hong Kong – 30 Mar 2012) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Juda International Holdings Limited** ("Juda International"; stock code: 01329) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Juda International** on **PhillipMart** were HK\$1.17 and HK\$1.13. The price closed at HK\$1.13 per share, 2.73% higher than its offer price of HK\$1.10. The price opened at HK\$1.17, with the most actively traded price of HK\$1.17 per share, and a turnover of 176,000shares. The total trading volume reached 184,000shares with total turnover of HK\$214,960.00. The final price of **Juda International**, to debut trading tomorrow has been fixed at HK\$1.10 per share.
