

**PhillipMart Announces Pre-IPO Share Price of
 Synertone Communication Corporation (Stock code: 01613)**

(Hong Kong – 17 April 2012) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Synertone Communication Corporation** (“Synertone”; stock code: 01613) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Synertone** on PhillipMart were HK\$0.35 and HK\$0.35. The price closed at HK\$0.35 per share, 6.06% higher than its offer price of HK\$0.33. The price opened at HK\$0.35, with the most actively traded price of HK\$0.35 per share, and a turnover of 272,000shares. The total trading volume reached 272,000shares with total turnover of HK\$95,200.00. The final price of **Synertone**, to debut trading tomorrow has been fixed at HK\$0.33 per share.
