

## PhillipMart Announces Pre-IPO Share Price of Haitong Securities Co., Ltd. (Stock code: 06837)

(Hong Kong – 26 April 2012) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Haitong Securities Co., Ltd.** ("Haitong Securities"; stock code: 06837) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Haitong Securities** on PhillipMart were HK\$10.88 and HK\$10.68. The price closed at HK\$10.72 per share, 1.13% higher than its offer price of HK\$10.60. The price opened at HK\$10.88, with the most actively traded price of HK\$10.72 per share, and a turnover of 599,600 shares. The total trading volume reached 1,318,000 shares with total turnover of HK\$14,145,808.00. The final price of **Haitong Securities**, to debut trading tomorrow has been fixed at HK\$10.60 per share.
