

**PhillipMart Announces Pre-IPO Share Price of
 Dongwu Cement International Limited (Stock code: 00695)**

(Hong Kong – 12 June 2012) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Dongwu Cement International Limited** (“Dongwu Cement”; stock code: 00695) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Dongwu Cement** on PhillipMart were HK\$1.28 and HK\$1.18. The price closed at HK\$1.28 per share, 16.36% higher than its offer price of HK\$1.10. The price opened at HK\$1.18, with the most actively traded price of HK\$1.18 per share, and a turnover of 30,000shares. The total trading volume reached 40,000shares with total turnover of HK\$48,080.00. The final price of **Dongwu Cement**, to debut trading tomorrow has been fixed at HK\$1.10 per share.
