

**PhillipMart Announces Pre-IPO Share Price of  
 Qualipak International Holdings Limited (Stock code: 01332)**

(Hong Kong – 11 July 2012) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Qualipak International Holdings Limited** (“Qualipak”; stock code: 01332) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Qualipak on PhillipMart were HK\$1.70 and HK\$1.64. The price closed at HK\$1.64 per share, 3.14% higher than its offer price of HK\$1.59. The price opened at HK\$1.64, with the most actively traded price of HK\$1.64 per share, and a turnover of 98,000 shares. The total trading volume reached 278,000 shares with total turnover of HK\$460,580. The final price of Qualipak, to debut trading tomorrow has been fixed at HK\$1.59 per share.
