PhillipMart Announces Pre-IPO Share Price of PRC B1407-R (Stock code: 86606)

(Hong Kong – 19 July 2012) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **PRC B1407-R** ("Bonds"; stock code: 86606) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Bonds on PhillipMart were CNY100.85 and CNY99.95. The price closed at CNY100.1 per share, 0.1% higher than its offer price of CNY100. The price opened at CNY100.7, with the most actively traded price of CNY100.1 per share, and a turnover of 5,500 shares. The total trading volume reached 14,400 shares with total turnover of CNY1,443,245. The final price of Bonds, to debut trading tomorrow has been fixed at CNY100 per share.
