

PhillipMart Announces Pre-IPO Share Price of Shanghai Fosun Pharmaceutical (Group) Co., Ltd (Stock code: 02196)

(Hong Kong – 29 Oct 2012) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Shanghai Fosun Pharmaceutical (Group) Co., Ltd** ("Fosun Pharma"; stock code: 02196) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Fosun Pharma** on **PhillipMart** were HK\$11.80 and HK\$11.02. The price closed at HK\$11.16 per share, 5.424% lower than its offer price of HK\$11.80. The price opened at HK\$11.80, with the most actively traded price of HK\$11.20 per share, and a turnover of 32,000 shares. The total trading volume reached 77,500 shares with total turnover of HK\$869,320.00. The final price of Fosun Pharma, to debut trading tomorrow has been fixed at HK\$11.80 per share.
