

## PhillipMart Announces Pre-IPO Share Price of CIFI Holdings (Group) Co. LTD. (Stock code: 00884)

(Hong Kong – 22 Nov 2012) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **CIFI Holdings (Group) Co. LTD.** ("CIFI Hold GP"; stock code: 00884) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for CIFI Hold GP on PhillipMart were HK\$1.33 and HK\$1.31. The price closed at HK\$1.33 per share, which same as its offer price of HK\$1.33. The price opened at HK\$1.33, with the most actively traded price of HK\$1.31 per share, and a turnover of 274,000 shares.
