

PhillipMart Announces Pre-IPO Share Price of Tsui Wah Holdings Limited (Stock code: 01314)

(Hong Kong – 23 Nov 2012) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Tsui Wah Holdings Limited ("Tsui Wah"; stock code: 01314) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Tsui Wah on PhillipMart were HK\$2.77 and HK\$2.38. The price closed at HK\$2.68 per share, 18.06% higher than its offer price of HK\$2.27 . The price opened at HK\$2.77 , with the most actively traded price of HK\$2.57 per share, and a turnover of 14,000 shares. The total trading volume reached 76,000 shares with total turnover of HK\$193,000 . The final price of Tsui Wah, to debut trading tomorrow has been fixed at HK\$2.27 per share.
