

## PhillipMart Announces Pre-IPO Share Price of Future Land Development Holdings Limited (Stock code: 01030)

(Hong Kong – 28 Nov 2012) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Future Land Development Holdings Limited** ("Future Land Development Holdings"; stock code: 01030) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Future Land Development Holdings on PhillipMart were HK\$1.47 and HK\$1.44. The price closed at HK\$1.45 per share, same as offer price of HK\$1.45. The price opened at HK\$1.46, with the most actively traded price of HK\$1.46 per share, and a turnover of 200,000 shares. The total trading volume reached 462,000 shares with total turnover of HK\$671,880. The final price of Future Land Development Holdings, to debut trading tomorrow has been fixed at HK\$1.45 per share.
