

PhillipMart Announces Pre-IPO Share Price of The People's Insurance Co. (Group) of China Limited (Stock code: 01339)

(Hong Kong – 6 Dec 2012) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **The People's Insurance Co.** (**Group**) of **China Limited** ("PICC"; stock code: 01339) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for on PhillipMart were HK\$3.75 and HK\$3.60. The price closed at HK\$3.60 per share, 3.448% higher than its offer price of HK\$3.48. The price opened at HK\$3.70, with the most actively traded price of HK\$3.64 per share, and a turnover of 7,328,000shares. The total trading volume reached 17,682,000shares with total turnover of HK\$64,388,980.00. The final price of PICC, to debut trading tomorrow has been fixed at HK\$3.48 per share.
