

## PhillipMart Announces Pre-IPO Share Price of China Machinery Engineering Corporation (Stock code: 01829)

(Hong Kong – 20 Dec 2012) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **China Machinery Engineering Corporation** ("CMEC"; stock code: 01829) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for CMEC on **PhillipMart** were HK\$6.13 and HK\$5.7. The price closed at HK\$6.04 per share, 11.852% higher than its offer price of HK\$5.4. The price opened at HK\$5.7, with the most actively traded price of HK\$ 6.1per share, and a turnover of 2,197,000shares. The total trading volume reached 15,167,000shares with total turnover of HK\$91,087,970.00. The final price of CMEC, to debut trading tomorrow has been fixed at HK\$5.4 per share.
