

PhillipMart Announces Pre-IPO Share Price of China Sliver Group Limited (Stock code: 00815)

(Hong Kong – 27 Dec 2012) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **China Sliver Group Limited** ("China Sliver Group"; stock code: 00815) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for China Sliver Group on **PhillipMart** were HK\$1.26 and HK\$1.20. The price closed at HK\$1.25 per share, 5.932% higher than its offer price of HK\$1.18. The price opened at HK\$1.20, with the most actively traded price of HK\$1.21 per share, and a turnover of 582,000shares. The total trading volume reached 2,084,000shares with total turnover of HK\$2,553,966. The final price of China Sliver Group, to debut trading tomorrow has been fixed at HK\$1.18 per share.
