

PhillipMart Announces Pre-IPO Share Price of Speedy Global Holdings Limited (Stock code: 00540)

(Hong Kong – 14 Jan 2013) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Speedy Global Holdings Limited** (“**Speedy Global**”; stock code: 00540) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Speedy Global** on PhillipMart were HK\$1.08 and HK\$0.95. The price closed at HK\$1.06 per share, 29.268% higher than its offer price of HK\$0.82. The price opened at HK\$0.95, with the most actively traded price of HK\$1.03 per share, and a turnover of 1,504,000shares. The total trading volume reached 6,468,000shares with total turnover of HK\$6,705,880.00. The final price of Speedy Global, to debut trading tomorrow has been fixed at HK\$0.82 per share.
