

## PhillipMart Announces Pre-IPO Share Price of GoldenWheel Tiandi Holdings Company Limited (Stock code: 01232)

(Hong Kong – 15 Jan 2013) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **GoldenWheel Tiandi Holdings Company Limited** (“**GoldenWheel Tiandi**”; stock code: 01232) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **GoldenWheel Tiandi** on PhillipMart were HK\$2.02 and HK\$1.88. The price closed at HK\$1.99 per share, 18.452% higher than its offer price of HK\$1.68. The price opened at HK\$1.88, with the most actively traded price of HK\$1.99 per share, and a turnover of 2,860,000shares. The total trading volume reached 11,520,000shares with total turnover of HK\$22,822,680.00. The final price of **GoldenWheel Tiandi**, to debut trading tomorrow has been fixed at HK\$1.68per share.
