

## PhillipMart Announces Pre-IPO Share Price of Chinalco Mining Corporation International (Stock code: 03668)

(Hong Kong – 30 Jan 2013) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Chinalco Mining Corporation International** ("Chinalco Mining"; stock code: 03668) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Chinalco Mining** on PhillipMart were HK\$1.75 and HK\$1.6. The price closed at HK\$1.64 per share, 6.857% lower than its offer price of HK\$1.75. The price opened at HK\$1.75, with the most actively traded price of HK\$1.64 per share, and a turnover of 1,650,000shares. The total trading volume reached 8,530,000shares with total turnover of HK\$14,024,780.00. The final price of Chinalco Mining, to debut trading tomorrow has been fixed at HK\$1.75 per share.
