

PhillipMart Announces Pre-IPO Share Price of Time Watch Investments Limited (Stock code: 02033)

(Hong Kong – 4 Feb 2013) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Time Watch Investments Limited** ("Time Watch"; stock code: 02033) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Time Watch on **PhillipMart** were HK\$1.65 and HK\$1.42. The price closed at HK\$1.56 per share, 15.556% higher than its offer price of HK\$1.35. The price opened at HK\$1.65, with the most actively traded price of HK\$1.5 per share, and a turnover of 4,998,000shares. The total trading volume reached 23,346,000 shares with total turnover of HK\$35,509,080.00. The final price of Time Watch, to debut trading tomorrow has been fixed at HK\$1.35 per share.
