

PhillipMart Announces Pre-IPO Share Price of PanAsialum Holdings Company Limited (Stock code: 02078)

(Hong Kong – 4 Feb 2013) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **PanAsialum Holdings Company Limited** ("PanAsialum"; stock code: 02078) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **PanAsialum** on PhillipMart were HK\$4.29 and HK\$3.9. The price closed at HK\$4.25 per share, 2.906% higher than its offer price of HK\$4.13. The price opened at HK\$4.12, with the most actively traded price of HK\$4.1 per share, and a turnover of 1,990,000shares. The total trading volume reached 9,650,000shares with total turnover of HK\$39,819,630.00. The final price of PanAsialum, to debut trading tomorrow has been fixed at HK\$4.13 per share.
