

PhillipMart Announces Pre-IPO Share Price of Xinchen China Power Holdings Limited (Stock code: 01148)

(Hong Kong – 12Mar 2013) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Xinchen China Power Holdings Limited** ("Power Xinchen"; stock code: 01148) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Power Xinchen on PhillipMart were HK\$ 2.25and HK\$2.21. The price closed at HK\$2.21 per share, 0.897% lower than its offer price of HK\$2.23. The price opened at HK\$2.23, with the most actively traded price of HK\$2.23 per share, and a turnover of 939,000shares. The total trading volume reached 1,194,000shares with total turnover of HK\$2,661,780.00. The final price of Power Xinchen, to debut trading tomorrow has been fixed at HK\$2.23 per share.
