

## PhillipMart Announces Pre-IPO Share Price of China Galaxy Securities Co. Limited (Stock code: 06881)

(Hong Kong – 21 May 2013) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **China Galaxy Securities Co. Limited** ("China Galaxy"; stock code: 06881) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **China Galaxy** on PhillipMart were HK\$5.75 and HK\$5.6. The price closed at HK\$5.74 per share, 8.302% higher than its offer price of HK\$5.3. The price opened at HK\$5.6, with the most actively traded price of HK\$5.7 per share, and a turnover of 9,176,500shares. The total trading volume reached 17,699,500shares with total turnover of HK\$100,895,785.00. The final price of China Galaxy, to debut trading tomorrow has been fixed at HK\$5.3 per share.
