PhillipMart Announces Pre-IPO Share Price of SINOPEC Engineering (Group) Co., Ltd. (Stock code: 02386)

(Hong Kong – 22 May 2013) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **SINOPEC Engineering (Group) Co., Ltd.** ("Sinopec Seg"; stock code: 02386) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Sinopec Seg** on **PhillipMart** were HK\$11.4 and HK\$11. The price closed at HK\$11.08 per share, 5.524% higher than its offer price of HK\$10.5. The price opened at HK\$11, with the most actively traded price of HK\$11.1 per share, and a turnover of 1,455,000shares. The total trading volume reached 4,865,000shares with total turnover of HK\$54,241,690.00. The final price of Sinopec Seg, to debut trading tomorrow has been fixed at HK\$10.5 per share.
