

**PhillipMart Announces Pre-IPO Share Price of
 Freetech Road Recycling Technology (Holdings) Limited (Stock code: 06888)**

(Hong Kong – 25 Jun 2013) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Freetech Road Recycling Technology (Holdings) Limited** (“**Freetech**”; stock code: 06888) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Freetech Road Recycling Tecnology** on PhillipMart were HK\$2.48 and HK\$2.38. The price closed at HK\$2.46 per share, 1.235% higher than its offer price of HK\$2.43. The price opened at HK\$2.43, with the most actively traded price of HK\$2.47 per share, and a turnover of 80,000shares. The total trading volume reached 120,000shares with total turnover of HK\$296,010.00. The final price of Freetech, to debut trading tomorrow has been fixed at HK\$2.43 per share.
