PhillipMart Announces Pre-IPO Share Price of Jin Cai Holdings Company Limited (Stock code: 01250)

(Hong Kong – 4 Jul 2013) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Jin Cai Holdings Company Limited ("Jin Cai Holdings"; stock code: 01250) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Jin Cai Holdings on PhillipMart were HK\$0.89 and HK\$0.85. The price closed at HK\$0.85 per share, 3.659% higher than its offer price of HK\$0.82. The price opened at HK\$0.85, with the most actively traded price of HK\$0.88 per share, and a turnover of 128,000shares. The total trading volume reached 388,000shares with total turnover of HK\$338,920.00. The final price of Jin Cai Holdings, to debut trading tomorrow has been fixed at HK\$0.82 per share.
