

**PhillipMart Announces Pre-IPO Share Price of
 Macau Legend Development Limited (Stock code: 01680)**

(Hong Kong – 4 Jul 2013) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Macau Legend Development Limited** (“**Macau Legend**”; stock code: 01680) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Macau Legend** on PhillipMart were HK\$2.38 and HK\$2.29. The price closed at HK\$2.3 per share, 2.128% lower than its offer price of HK\$2.35. The price opened at HK\$2.35, with the most actively traded price of HK\$2.31 per share, and a turnover of 120,000shares. The total trading volume reached 337,000shares with total turnover of HK\$783,010.00. The final price of **Macau Legend**, to debut trading tomorrow has been fixed at HK\$2.35per share.
