

**PhillipMart Announces Pre-IPO Share Price of  
 Sinosoft Technology Group Limited (Stock code: 01297)**

(Hong Kong – 8<sup>th</sup> Jul 2013) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Sinosoft Technology Group Limited** (“Sinosoft Tech”; stock code: 01297) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Sinosoft Technology Group Limited** on PhillipMart were HK\$1.55 and HK\$1.46. The price closed at HK\$1.49 per share, 2.759% higher than its offer price of HK\$1.45. The price opened at HK\$1.55, with the most actively traded price of HK\$1.48 per share, and a turnover of 230,000shares. The total trading volume reached 918,000shares with total turnover of HK\$1,372,000. The final price of **Sinosoft Technology**, to debut trading tomorrow has been fixed at HK\$1.45 per share.
