

# PhillipMart Announces Pre-IPO Share Price of

## S. Culture International Holdings Limited (Stock code: 01255)

(Hong Kong – 10 Jul 2013) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **S. Culture International Holdings Limited** ("**S. Culture**"; stock code: 01255) PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **S. Culture International Holdings Limited** on PhillipMart were HK\$2.24 and HK\$2.15. The price closed at HK\$2.15 per share, 0.939% higher than its offer price of HK\$2.13. The price opened at HK\$2.19, with the most actively traded price of HK\$2.2 per share, and a turnover of 206,000shares. The total trading volume reached 358,000shares with total turnover of HK\$787,720,000. The final price of **S. Culture**, to debut trading tomorrow has been fixed at HK\$2.13 per share.
