

PhillipMart Announces Pre-IPO Share Price of Wisdom Holdings Limited (Stock code: 01661)

(Hong Kong – 10 Jul 2013) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Wisdom Holdings Limited** ("Wisdom"; stock code: 01661) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Wisdom Holdings Limited** on PhillipMart were HK\$2.05. The price closed at HK\$2.05 per share, 2.844% lower than its offer price of HK\$2.11. The price opened at HK\$2.05, with the most actively traded price of HK\$2.05 per share, and a turnover of 100,000shares. The total trading volume reached 100,000shares with total turnover of HK\$205,000. The final price of Wisdom, to debut trading tomorrow has been fixed at HK\$2.11 per share.
