

**PhillipMart Announces Pre-IPO Share Price of
 Grand Ming Group Holdings Limited (Stock code: 01271)**

(Hong Kong – 8 Aug 2013) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Grand Ming Group Holdings Limited** (“**Grand Ming Group**”; stock code: 01271) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Grand Ming Group** on PhillipMart were HK\$1.21 and HK\$1.16. The price closed at HK\$1.19 per share, 7.207% higher than its offer price of HK\$1.11. The price opened at HK\$1.21, with the most actively traded price of HK\$1.19 per share, and a turnover of 2,012,000 shares. The total trading volume reached 5,740,000 shares with total turnover of HK\$6,810,000. The final price of Grand Ming Group, to debut trading tomorrow has been fixed at HK\$2.15 per share.
