## PhillipMart Announces Pre-IPO Share Price of Tenwow International Holdings Limited (Stock code: 01219)

(Hong Kong – 16 Sep 2013) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Tenwow International Holdings Limited** ("**Tenwow International**"; stock code: 01219) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Tenwow International** on PhillipMart were HK\$3.34 and HK\$3.2. The price closed at HK\$3.27 per share, 3.81% higher than its offer price of HK\$3.15. The price opened at HK\$3.28, with the most actively traded price of HK\$3.28 per share, and a turnover of 1,851,000shares. The total trading volume reached 6,211,000shares with total turnover of HK\$20,374,620.00. The final price of **Tenwow International**, to debut trading tomorrow has been fixed at HK\$3.15 per share.
