

**PhillipMart Announces Pre-IPO Share Price of  
 CT Environmental Group Limited (Stock code: 01363)**

(Hong Kong – 24 Sep 2013) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **CT Environmental Group Limited** (“**CT Environmental**”; stock code: 01363) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **CT Environmental** on PhillipMart were HK\$1.54 and HK\$1.49. The price closed at HK\$1.50 per share, 1.35% higher than its offer price of HK\$1.48. The price opened at HK\$1.49, with the most actively traded price of HK\$1.52 per share, and a turnover of 74,000shares. The total trading volume reached 350,000shares with total turnover of HK\$531,000.00. The final price of **CT Environmental**, to debut trading tomorrow has been fixed at HK\$1.48 per share.
